  - Fair Update
    - i. The June 15<sup>th</sup> still carries lots of unknowns like ABC Permits, temporary food permits which were just not approved this last week for two other events, Vaccine requirements, Testing results, and many other factors that make the full fair still not a viable option. If we are to be here for the years to come, then we need to fiscally look at what we can do this year and a full fair with all the unknowns is just too risky. Instead, we will stick with the 3 different items we discussed at the April 5<sup>th</sup> meeting and if by chance the June 15<sup>th</sup> date is an actual and we do get better guidance as right now there is not anything and we are being told to still follow for amusement parks and the guidance is doable then we can add other summer events like a rodeo or a demolition derby. But right now, with so many unknowns and unforeseen items it is not fiscally responsible to plan for a fair that we know is going to be astronomical in funds to do but have no guarantee on the money we will generate.
